Day 1 – Monday – March 6: Flight Overnight flight from USA to Tel-Aviv.

Day 2 - Tuesday - March 7: Arrival - Jaffa - Herzeliya

Upon arrival at Ben Gurion airport you will be met and assisted by a Coral Travel & Tours representative at the airport. Meet your guide and drive to **Jaffa** for a walking tour of the old city. Jaffa has been known in the bible as Joppa and is considered the world's oldest port and the place where the prophet Jonah set sail for Tarshish. Jaffa is associated with the deeds of Peter. Drive to hotel in Herzeliya. Dinner and overnight: Hotel in Herzeliya.


Day 3 - Wednesday - March 8: Caesarea - Mt. Carmel - Megiddo - Cana

After breakfast drive along the Sharon Plane to Caesarea, the seat of the Roman Procurator of Judea at the time of the Christ, and the site where Peter converted the centurion Cornelius. This fortified harbor city was built 2000 years ago by King Herod the Great. View the ruins of Roman, Byzantine and Crusader times. Explore the Roman Theater and the Aqueducts. A drive up to Mt. Carmel will bring us to the site where Elijah challenged and defeated the 450 prophets of Baal. Continue to Megiddo, the Fortress City of King Solomon, later built again by King Ahab. The books of Daniel and Revelation will come alive as we study about the final Battle of Armageddon. Stop at Mount Precipice for an overview of Nazareth. Visit Nazareth Village. Drive through Cana of Galilee to Tiberias. Dinner and overnight: Hotel near the Sea of Galilee.

Day 4 - Thursday - March 9: Around the Sea of Galilee

This morning visit **Capernaum**, the town Jesus made his home after leaving Nazareth. Capernaum is the place where Jesus recruited the first of His disciples (Matthew 4:13, Luke 4:31-37, Matthew 8:14-17, Mark 2:1-12, Matthew 8:5-13, Mark 5:21-43, Matthew 11:23-24). Visit the excavation of the ancient synagogue and the house of Peter. Continue to **Tabgha**, the site of the multiplication. Take a **boat ride** on the Sea of Galilee. Visit **Kibbutz Ginnosar** to see **the ancient boat**, believed to be from Jesus' time. Visit the **Mt. of Beatitudes**, where Jesus delivered the Sermon on the Mount (Matthew 5:1-12). You will also visit **Kursi** and **Magdala** today. Dinner and Overnight: Hotel near the Sea of Galilee.

Day 5 – Friday – March 10: Tel Dan – Caesarea Philippi – Mt. Hermon – Mt. Bental After breakfast drive to Tel Dan, an important biblical city and a breathtaking Nature Reserve. The bible mentions the city a few times: "From Dan to Beer Sheba". Continue to the Banias, site of ancient Caesarea Philippe. It is here that Peter made his confession of faith in Jesus (Matthew 16:13). Continue on to the Valley of Tears and review Israel's miraculous victory in the Yom Kippur War. From Mt. Bental you will have an overview of the Golan Heights and Syria. End the day at Yardenit with an opportunity to be baptized



Day 6 – Saturday – March 11: Gideon Spring – Jericho – Qumran – Dead Sea

Leave the Sea of Galilee and drive to **Ein Harod**, the site of Judge Gideon (Judges 7: 1-25). Continue through the Jordan Valley with a stop at an overview of **Jericho**, believed to be the world's oldest walled city. This was the first city taken by Joshua when the Hebrews returned from Egypt – 'and the walls fell down.' It was also the site of the Mount of Temptation (Mark 1:13). Drive along the shores of the Dead Sea to **Qumran**, where the 2000 years old Dead Sea Scrolls were found. End the day at your hotel located on the Shore of the Dead Sea. Dinner and overnight: Hotel at the Dead Sea.

Day 7 - Sunday - March 12: Massada - Ein Gedi - Jerusalem - Mt. Scopus

For those who want to participate, there will be an option to leave the hotel early morning to hike up the Snake Trail of Massada. The rest will depart later and ascend Massada by cable car. Massada is the site of the most dramatic act in Jewish History. Explore the ancient excavation of Herod's Palaces, the bathhouse, the storerooms, the Ramp, and the oldest Synagogue in the world. Continue on to Ein Gedi, an Oasis on the Dead Sea shore. Near the 200-meter-high waterfall is a cave where David had his famous meeting with King Saul (1 Samuel 24: 1-23). A walk around the reservation confirms that Ein Gedi is one of the most beautiful reservations in the world. Drive to Jerusalem. Enter the city of Jerusalem in the traditional way and view the city from Mt. Scopus. Dinner and overnight: Hotel in Jerusalem.

Day 8 - Monday - March 13: Israel Museum - Bet Shemesh - Ella Valley - Valley of Aijalon - Shepherd's Fields

This morning drive to the western side of the city and visit the Israel Museum, the Shrine of the Book (where some of the Dead Sea Scrolls and Bar Kokhva letters are exhibited) and the Holy Land Model. Then, drive out of Jerusalem to Bet Shemesh and then to the Ella Valley, the site of the battle of David and Goliath. Continue to the Valley of Aijalon where Joshua defeated the Southern kings and the Lord caused the sun to stand still for a day. Your last stop today will be Shepherds Fields outside of Bethlehem. Return to Jerusalem. Dinner and overnight: Hotel in Jerusalem.

Day 9 - Tuesday - March 14: Jerusalem

After breakfast ascend the Mt. of Olives (Matthew 24:3, Luke 21:37) for a breathtaking panoramic view of the old city of Jerusalem. Walk along the Palm Sunday Way to the Garden of Gethsemane (Matthew 26:36-46, Luke 22:39-45, Mark 14:32-42) where Jesus spent the last night before he was arrested. At Mt. Zion visit the City of David, Hezekiah's Tunnel or the Canaanite Tunnel. Visit also the Pool of Salome, the Davidson Center, the Southern Wall steps and the Herod's Palace near the tower of David. Dinner and overnight: Hotel in Jerusalem.

Day 10 - Wednesday - March 15: Jerusalem

This morning ascend **Mt. Moriah** (Luke 2:46-48, John, 8:1-11, Mark 13:1-2, Matthew 27:51). Walk up to the **Temple Mount** and view the Dome of the Rock and the El Aqsa Mosque. See the **Pools of Bethesda**. Walk through the **Christian Quarter** to the **Jewish Quarter** to the **Western Wall**, one of last remnants of the second Jewish Temple. You will also visit the **Rabbinical Tunnel**. At the western side of the city visit **Yad Vashem**, the Holocaust Museum. Dinner and overnight: Hotel in Jerusalem.

Day 11 - Thursday - March 16: Jerusalem

After breakfast drive to Mt. Zion and visit the **House of the High Priest Caiphas** and the **Church of Peter in Gallicantu** (Matthew 26:31-35). This is the place where Peter denied the Lord 3 times. Continue for a visit to the **Upper Room** (Mathew 26:17-25). End the day at **Golgotha** and the **Garden Tomb. Farewell dinner.** Overnight: Hotel in Jerusalem.

Day 12 - Friday - March 17: Jerusalem

Free day. Dinner at Hotel. Late check out from Hotel. Transfer to the airport for flight home.

Day 13 - Saturday - March 18: Tel Aviv - USA

Overnight flight back to the USA. Arrive the same day.
