# Day 1 – Monday November 7: Flight Overnight flight from USA to Tel-Aviv

Day 2 - Tuesday - November 8: Arrival - Jaffa - Herzeliya


Upon arrival at Ben Gurion airport you will be met and assisted by a Coral Travel & Tours representative at the airport. Meet your guide and driver and drive to visit **Jaffa**. Jaffa is known in the Bible as Joppa. Jaffa is considered the world's oldest port and the place where the prophet Jonah set sail for Tarshish. Jaffa is associated with the deeds of Peter. Here Tabitha was resurrected by St. Peter. The house of Simon the Tanner is located in Jaffa. Travel along the Sharon Plains to Herzeliya. Dinner and overnight: Hotel in Herzeliya.

# Day 3 – Wednesday – November 9: Caesarea – Mt. Carmel – Megiddo – Sea of Galilee

After breakfast drive to **Caesarea**. Caesarea was the seat of the Roman Procurator of the Judea in the time of Christ and is the place St. Peter converted the centurion Cornelius. Explore the Roman theatre, the aqueduct and view the ruins of the Roman, Byzantine and Crusader times. Continue to **Mt. Carmel**, to the **"Mukhraka"**, the site where Elijah challenged and defeated the 450 prophets of Baal. If time permits, drive via the ancient "Way of the Sea" to **Megiddo**, the fortress city of King Solomon, late built by King Ahab. The books of Daniel and Revelation will come alive as we study about the final Battle of Armageddon. View the plains of Jezreel. Drive through **Nazareth**, the home of Joseph and Mary and through the city of **Cana** of Galilee, where Jesus performed his first miracle: turning jars of water into wine. Drive to **Tiberias** at the Sea of Galilee. Dinner and overnight: Hotel in Tiberias.

Day 4 - Thursday - November 10: Sea of Galilee - Golan Heights

After breakfast drive to the **Banias**, site of the ancient **Caesarea Philippi**. It is here that Peter made his confession of faith in Jesus. Enjoy a panoramic view of the Golan Heights from **Mt. Bental**. Visit the **ancient boat** believed to be from Jesus' time at **Kibbutz Ginosar**. Continue on to **Capernaum**, the town Jesus made his home after leaving Nazareth. Visit the excavations of the ancient Synagogue and the house of St. Peter. Take a **boat ride** on the Sea of Galilee. Visit the **Mt. of Beatitudes** where Jesus delivered the Sermon on the Mount. Then, visit **Tabgha**, the site of the multiplication of the loaves and fishes. Visit **Carazim** Dinner and overnight: Hotel in Tiberias



# Day 5 - Friday - November 11: Jordan River - Bet She'an - Jerusalem

After breakfast drive to the **Jordan River** with an opportunity to be **baptized**. Leave the Sea of Galilee and drive to **Bet She'an**. Recent excavations there have disclosed the impressive ruins of the country's largest city in the Roman and Byzantine periods, which was destroyed by an earthquake in 749 CE. The tour continues through the Jordan Valley to **Jericho**, believed to be the oldest walled city. This was the first city taken by Joshua when the Hebrews returned from Egypt and was also the site of the **Mt. of Temptation**. Drive to Jerusalem and pass the site of the Good Samaritan Inn. Enter the city of **Jerusalem** in a traditional way and view the city from the Mt. of Olives. Dinner and overnight: Hotel in Jerusalem.

## Day 6 - Saturday - November 12: Jerusalem

After breakfast we'll ascend the **Mount of Olives** (Matthew 24:3, **Luke 21:37**) for a breathtaking panoramic view of the old city of Jerusalem. Walk along the **Palm Sunday Way**. Descend to the **Garden of Gethsemane** (Matthew 26:36-46, Luke 22:39-45, Mark 14:32-42) where Jesus spent the last night before he was arrested. Visit the **Church of All the Nations**. Walk along the "**Last Way**" to Mt. Zion. Cross the **Kidron Valley** and see the **Tombs of Absalom, Zachary** and **James**. Drive to **Mount Zion** and visit the house of the high priest **Caiphas**. Visit the **Church of Peter in Gallicantu** (Matthew 26:31-35). This is the place where Peter denied the Lord 3 times. Continue on to **the Last Supper Room** (Matthew 26: 17-25) and **King David's Tomb**. Visit the **Jewish Quarter**, the **Western Wall**, one of last remnants of the second Jewish Temple and the **Davidson Center (Southern Wall excavations)**. Today we will also visit **St. Anne's Church**, which is a fine example of Crusader architecture and the **Pools of Bethesda**. Dinner and overnight: Hotel in Jerusalem.

## Day 7 - Sunday - November 13: Qumran - Dead Sea - Massada- Bethlehem

After breakfast depart from Jerusalem to the Dead Sea and visit **Massada**. Massada is the site of the most dramatic act in the Jewish History. Explore the ancient excavations of Herod's Palaces, the bathhouse, the storerooms, the ramp and the oldest synagogue in the world. Continue to **Qumran**, where the 2,000 year old Dead Sea Scrolls were found. Continue on to the Dead Sea shore for an afternoon float on the sea. Return to Jerusalem. On your way back visit **Bethlehem** and the **Church of Nativity.** Dinner and overnight: Hotel in Jerusalem.

# Day 8 - Monday - November 14: Jerusalem

After breakfast drive to **Mt Moriah** (Luke 2:46-48, John, 8:1-11, Mark 13:1-2, Matthew 27:51). Walk up to the Temple place and visit the Dome of the Rock and the El Aqza Mosque. Drive to the western side of the city and the **Menorah** at the Knesset (Israel Parliament). Continue to **Yad Vashem**, the **Holocaust Museum**. End the day at the **Garden Tomb**. **Farewell dinner**. Overnight: Hotel in Jerusalem .
