Day 1 – March 7 - Monday: USA – Tel Aviv Overnight flight to Tel Aviv.

#### Day 2 - March 8 - Tuesday: Tel Aviv - Jaffa


Arrive at Ben Gurion Airport near Tel Aviv. You will be met and assisted by a Coral Travel and Tours representative inside the terminal. Meet your guide and driver and drive to your hotel in Tel Aviv. After dinner visit **Jaffa**, one of the oldest cities in the world. Visit the House of Simon the Tanner and walk through Jaffa's reconstructed Old Quarter. Dinner and overnight: Hotel in Tel Aviv.

## Day 3 - March 9 - Wednesday: Caesarea - Megiddo - Sea of Galilee

Depart Tel Aviv and travel along the Sharon plans to Caesarea, the seat of the Roman Procurator of Judea at the time of the Christ, and the site where Peter converted the centurion Cornelius. This fortified harbor city was built 2000 years ago by King Herod the Great. View the ruins of Roman, Byzantine and Crusader times. Explore the Roman Theater and the Aqueducts. A drive up Mt. Carmel will bring us to the site where Elijah challenged and defeated the 450 prophets of Baal. For lunch (on your own) we will stop at a Druze Village. Continue to Megiddo, the Fortress City of King Solomon, later built again by King Ahab. The books of Daniel and Revelation will come alive as we study about the final Battle of Armageddon while viewing the Plains of Jezreel. Continue on to Mt. Precipice (Luke – 25/4). Drive to Tiberias. Dinner and overnight: Hotel in Tiberias.

#### Day 4 - March 10 - Thursday: Sea of Galilee

The day starts with a visit to Kibbutz Nof Ginnosar to see the 2000 year-old ancient boat. After a boat ride on the Sea of Galilee visit the ruins of Capernaum, the town where Jesus made his home after leaving Nazareth. Drive to the Mt. of Beatitudes, site of the Sermon on the Mount. Continue to the Southern Golan Heights and stop at the Peace Vista site. End the day at Yardenit, the Baptismal Center site on the Jordan River in Israel where you will have an opportunity to be baptized (optional). Dinner and overnight: Hotel in Tiberias.



Day 5 - March 11 - Friday: Bet She'an - Jordan Valley - Jerusalem

After breakfast drive to **Bet She'an** where recent excavations have unveiled the impressive ruins of the country's largest city in the Roman and Byzantine periods, which was destroyed by an earthquake in 749 AD. Drive along the **Jordan Valley** to Jerusalem and on the way pass **Jericho**, believed to be the world's oldest walled city. This was the first city taken by Joshua when the Hebrews returned from Egypt – 'and the walls fell down' - and was also the site of the Mt. of Temptation. Enter the city of Jerusalem in a traditional way. Stop at **Quasar El Yehud.** Ascend the **Mt. of Olives** for a breathtaking panoramic view of the Old City of Jerusalem. Walk along the **Palm Sunday Way. Visit Dominus Flevit** and descend to the **Garden of Gethsemane** where Jesus spent the last night before he was arrested. Dinner and overnight: Hotel in Jerusalem.

Day 6 - March 12 - Saturday: Massada - Ein Gedi - Qumran - Dead Sea

After breakfast depart Jerusalem and descend to the Dead Sea. Drive along the shores of the Dead Sea to **Massada**, the site of the most dramatic act in Jewish History. Ascend by cable car. Explore the ancient excavations of Herod's palaces, the bathhouse, the storerooms, the ramp, and the oldest synagogue in the world. Continue to **Ein Gedi**, an oasis on the Dead Sea shore and the site where David hid from King Saul (First Samuel 24: 1-23). A walk around the park confirms that Ein Gedi is one of the most beautiful reservations in the world. Continue on to **Qumran**, where the 2000 years old Dead Sea Scrolls were found. Enjoy your hotel spa facilities or "float" on the water of the Dead Sea. Dinner and overnight: Hotel in Jerusalem.

Day 7 - March 13 - Sunday: Jerusalem

This morning drive to Mt. Zion. Visit the Last Supper Room on Mt. Zion and King David's Tomb. Enter the Old City via the Zion Gate. Visit the Cardo, the Wide Wall. Visit the Rabbinical Tunnel. Walk along the Via Dolorosa, the Way of the Cross, to the Church of the Holy Sepulchre. Walk through the colorful Bazaar to the Jaffa Gate. Free time for shopping in the afternoon. Dinner and overnight: Hotel in Jerusalem.

Day 8 - March 14 - Monday: Jerusalem

In the morning drive through the Knesset (Israeli Parliament) and visit the famous Menorah (the official sign of the State of Israel). Proceed to the Israel Museum to see the Shrine of the Book where the Dead Sea Scrolls are kept and the Holy Land walk-around model of the city of Jerusalem as it was in the 2nd Temple period (the time of Jesus). Continue for a visit to Yad Vashem, the National Holocaust Museum. We'll end our visit in Jerusalem with a service at the Garden Tomb. Farewell dinner. Overnight: Hotel in Jerusalem.

Day 9 - March 15 - Tuesday: Tel Aviv - USA

Early morning transfer to the airport for your flight home. Arrive in USA the same day.
